The Villere Balanced Fund seeks to achieve long-term capital growth consistent with preservation of capital and balanced by current income.

INVESTMENT STRATEGY

Our investment philosophy is built on our core belief that growth can and should be achieved at a reasonable price. We:

- Manage a high conviction, concentrated equity portfolio of Villere’s 20-30 best ideas
- Employ a bottom-up research process to identify mispriced securities and unique opportunities
- Seek long-term relative outperformance through active management and selective investing
- Invest with a bias toward small-and mid-sized companies
- Have a long-term investment time horizon—low turnover
- Use a 20-50% fixed income allocation to balance the risk in the Fund

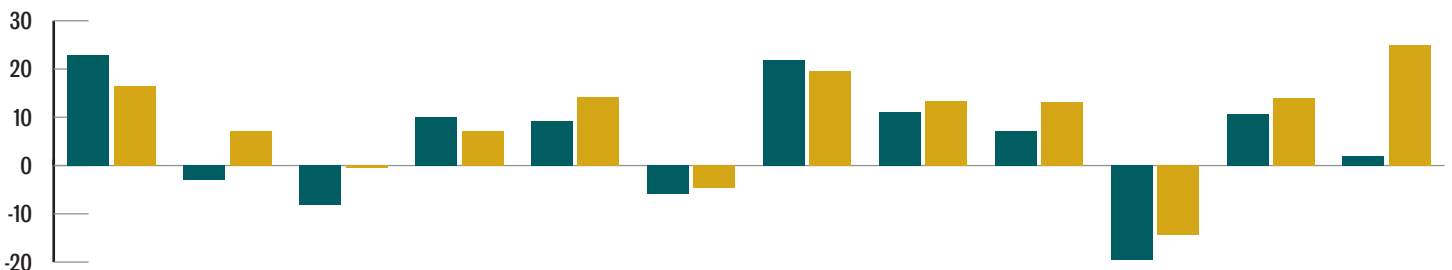

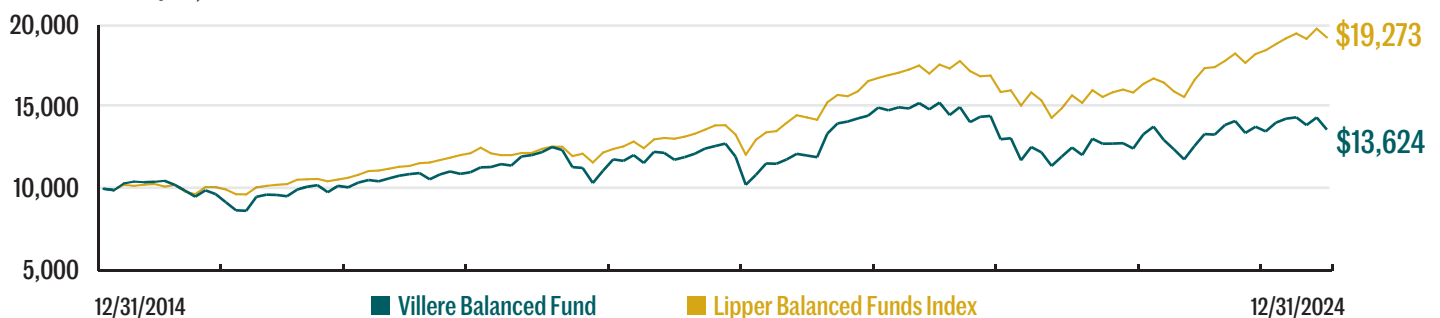

P/E Ratio is the weighted average of the price/earnings ratios of the equities held by the Fund. P/E ratio is a company's current stock price divided by its estimated next 12-months' earnings per share. **Market Cap** is the market price of an entire company, calculated by multiplying the number of shares outstanding by the price per share. **Turnover Ratio** is a measure of the fund's trading activity that is computed by taking the lesser of purchases or sales (excluding all securities with maturities of less than one year) and dividing by average monthly assets. **Average Duration** is a commonly used measure of the potential volatility of the price of a debt security, or the aggregate market value of a portfolio of debt securities, prior to maturity. Securities with a longer duration generally have more volatile prices than securities of comparable quality with a shorter duration. **Lipper Balanced Funds Index** is an equity weighted performance index of the largest qualifying funds in the Lipper Category. **S&P 500** is an unmanaged index which is widely regarded as the standard for measuring large-cap U.S. stock market performance. The stock index does not incur expenses and is not available for investment. **Bloomberg US Intermediate Government/Credit Bond Index** measures the performance of U.S. Dollar denominated U.S. Treasuries, government-related and investment grade U.S. corporate securities that have a remaining maturity of greater than one year and less than ten years. One cannot invest directly in an index.
